## TERMS & CONDITIONS FOR SUPPLY OF FURNITURE ON HIRE BASIS

1. The bidders must have the experience of the similar supply work.

2. All the furniture items must be in good condition, reliable brand and should be preferably new.

3. All the items will require to installed at Camp office of this Directorate in Old GMC Building, Campal, Panaji, Goa. No transportation/cartage/Installation/Labour charges/maintenance cost etc. will be paid against the supply.

4. The Rates for furniture (per day per item) and rate for carpet per feet should be quoted for every items. If any item is left out then the bid will be rejected. As the rates will be compared on Grand Total basis (not item wise). The Rates should be mentioned on per day basis/per feet for each & every item.
